Annual Fees

Pre-application Fee	75€	The pre-application fee is paid after the first meeting with the school, to continue the Pre-application Fee admission process.
Enrolment Fee (Early Years & Primary)	780€	The enrolment fee is paid to guarantee the vacancy for the academic year.
Enrolment Fee (Lower Secondary)	1200€	The enrolment fee is paid to guarantee the vacancy for the academic year.
Re-enrolment Fee	500€	The re-enrolment fee is paid to secure a place for the next academic year.
Insurance Fee	48€	The insurance fee is compulsory for every student enrolled.

2026-27 Fees Information

By accepting the above conditions, families commit to the student remaining enrolled and paying school fees for the full academic year. Any request to terminate the annual contract before the end of this period must be submitted to the School Management for review.

Pre-Enrolment Fee, Enrolment Fee

The amounts paid for these items are **non-refundable in the event of withdrawal or cancellation of enrolment**.

The re-enrolment fee will be invoiced and charged between **January-March** of each academic year.

Enrolment and re-enrolment are based on the agreement of both parents or legal guardians. In the absence of such agreement, the School reserves the right not to accept the enrolment or re-enrolment of the student.

School Insurance Fee

Annual school insurance is not optional and is invoiced annually to all students with the first monthly fee of each academic year.

Monthly / Annual Instalments

The monthly fee includes tuition and meals (morning snack, lunch, and afternoon snack).

For Early Years, the monthly fee does not cover hygiene products such as nappies, wipes, bed linen, or similar items.

The monthly fee does not include the uniform, textbooks, or school materials.

Payment of the monthly fee is preferably made by direct debit. Alternatively, payment can be made via bank transfer, education cheque, or ATM reference.

Payments can be made in two ways:

- Annual instalment:** payment by the end of September;
- Monthly instalment:** 11 instalments for Early Years and Primary (September to July, full months) and 10 instalments for Lower Secondary (September to June, full months).

In cases of illness or absence from school, **no refunds or reductions apply** to the applicable tuition instalments.

The school has specific closure days, which are communicated annually through the school calendar. The annual tuition fee already accounts for all scheduled closure days; therefore, **no refunds or fee reductions apply in relation to these days**.

Exceptional Cases:

- Students admitted after the 20th** of the month, between October and July of each academic year, will be charged 50% of the monthly tuition fee in the month of admission, as defined in the School Fees.
- If a child only begins attending from February** onwards, a 50% discount on the enrolment renewal fee will apply.

Financial Information

Invoices are issued at the beginning of each month and must be paid **by the 8th**. Overdue invoices incur a penalty of **€50 for each month of delay**.

Pre-enrolment, enrolment, re-enrolment, school insurance, and monthly fees are exempt from VAT, in accordance with Article 53 of the VAT Code.

The **financial details** provided in the Enrolment Form on the Admissions Portal, which determine invoice issuance, cannot be amended during the school year, including:

- Invoicing entity;
- NIF of the invoicing entity;
- Address of the invoicing entity;
- Option for monthly or annual invoicing.

Discounts on Tuition Fees

Families with more than two childrens enrolled at the School benefit from a discount applied to the youngest child:

% 1st Sibling - 5%**

% 2nd Sibling or more - 10%**

****Sibling discounts apply exclusively to the school fee.**

Extracurricular Activities

Participation in any extracurricular activity requires the payment of a registration fee, which will be invoiced in the month the activity begins.

All extracurricular activities are billed on a monthly basis and require a minimum commitment of three months.
